With the automation e-Invoicing provides, manufacturers can pay invoices quickly and take advantage of early-payment discounts. And the solution offers visibility into an organization's AP processes to help improve and accelerate manufacturers' transformation into agile and flexible digital businesses.

Ensure invoices comply with regulations

In much of the world, sending and receiving invoices electronically requires compliance with government regulations. Increasingly, these regulations are becoming mandatory for both business-to-government (B2G) and business-to-business (B2B) invoice transactions. Mandates require invoices to be submitted directly to a tax authority or a government-approved portal or agent before they can be sent to customers. Maintaining compliance with these complicated requirements, which differ from country to country, is a significant challenge for global manufacturers. However, if e-Invoices are not in the proper format to comply with local government regulations, manufacturers can face serious fines or even the threat of closure in certain countries.

Further complicating the e-Invoicing process, governments require an archive of electronic documents including the e-Invoice and supporting evidence when paper is eliminated from the invoicing process.

Compliant e-Invoicing for Global Manufacturing validates data to help manufacturers meet government mandates in more than 45 countries. The solution provides archiving with specific capabilities to support auditor access and review of archived e-Invoices and supporting documents to demonstrate compliance and shorten tax audits.

OpenText helps organizations meet government mandates for e-Invoicing including:

- Integration with government sponsored portals such as PEPPOL, SdI in Italy and Chorus Pro in France
- Translation to and from government-mandated formats such as eFattura and PEPPOL BIS
- Access by government agencies or certified partners such as PACs in Mexico to view and/or approve e-Invoices before they are sent to customers
