With exponentially increasing emails, ubiquitous versions of digital documents and big data breathing down our necks, agencies are concerned about how to reconcile information to support transparency, streamline operations, mine their data for trends and decision support and ensure compliance with litigation requirements.

### Digital record compliance

OpenText Digital Record Compliance solution provides agencies a platform that integrates and rationalizes data from across the organization, making it transparent to all authorized users, secure (in the cloud, if desired), compliant with a wide range of global standards and federal laws and regulations, including DOD 5015.2 and MoReq 2010. Digital Record Compliance stores and provides access to both structured and unstructured data, from all sources, converting it to digital, automatically classifying it with minimal human intervention, to make it searchable, subject to electronic e-discovery, and defensible.

The solution manages digital information across the agency (and, if appropriate, integrates with other agencies) in support of daily operations, enabling data management to and from mobile and social sources as it is needed. Digital Record Compliance provides visibility across the agency for IT governance and data management and reduces cyber risk by eliminating data duplication and including automatic disposition per policy. It also reduces agency storage costs not only by harmonizing and standardizing data but also by archive compression.

### Financial and audit compliance

For departments and agencies, clean financial system compliance and the time required to respond to auditors mandate clear accountability and auditability in agency accounting processes. Many existing processes and supporting ERP systems do not fully align with current agency goals. Transparency, information integrity, internal controls, and supporting documentation across the budget and acquisition lifecycle, are critical to fiduciary stewardship and audit readiness for all government entities across the globe.

The OpenText Financial and Audit Compliance solution is designed to meet the demanding compliance requirements of the US Department of Defense (DOD) FIAR (Financial Improvement Audit Readiness) mandate. It ensures that financial records have complete information and offers specific capabilities to automatically search files to identify and compile complete sample packages requested by auditors without affecting the integrity of the source documents.

Financial and Audit Compliance automates the current manual audit sampling process and streamlines the manual process of reviewing thousands of documents for sampling. It ensures the appropriate information is properly classified, secured, provided as needed, and retired per agency policy. Further, it unites information across existing legacy platforms and integrates with business-critical ERP system information, enabling bidirectional auto updates (and audit trail) when associated information is changed in either the source system or content server.

### ERP augmentation

The ERP Augmentation solution from OpenText is made for the complex, secure, regulation-driven government environment. The solution extends standard SAP, Oracle or other ERP system capabilities to provide content lifecycle management from document management to capture, collaboration, and workflow. It enables cost-saving archiving and enhanced, compliant (with DOD 5015.2, MoReq 2010 and more) content management of information from your ERP system and other sources across your organization.

ERP Augmentation allows users more powerful search capabilities from within and outside the ERP, as well as flexible, easy-to-use user views, reports, and content-enriched processes, ranging from program, quality, and case management to enterprise asset management and maintenance management. Our ERP Augmentation solution also includes anti-fraud capabilities. It unifies SAP, Oracle or other ERP systems with emails, social media, videos, photos, drawings, presentations and other structured and unstructured information, reducing risk and enhancing operational effectiveness. It offers workflow, as well as the ability to automatically update content when it is changed either in the content server or the ERP system to ensure a single source of truth for agency decision making and metrics.

### Digital Information Readiness (DIR)

To actualize the benefits and reap the savings of big data, open data, IT consolidations, modernization, and cloud hosting across government, you need to digitize, find, and rationalize data across your agency before it is used to fuel streamlined enterprise processes, analytics, or migrated to the cloud. The old

adage “garbage in, garbage out” could not be more accurate. DIR pulls your data from wherever it resides, presents it for review, and automates reconciling and standardizing it to prepare it for use. DIR sets up a foundation for lifecycle governance of content and data, bi-directional, in your existing IT landscape or the cloud, migrated on your timetable and within your budget.

DIR uses sophisticated semantic search, content analytics, and sentiment analysis tools to automate culling the data, fine-tuning decisions as you progress to identify where you can consolidate, reduce duplication, or eliminate data to be migrated. DIR provides a full audit trail throughout this process.

Knowing that your analytics software is applying its algorithms to valid content and data in context from across your organization is essential to deriving the value that big data projections anticipate. DIR enables you to ensure that the content that will inform decisions and agency policy is accurate and harmonized.
