- Taking a precautionary approach that integrates consideration of environmental concerns and impacts into our decision-making and activities, including procurement processes and leasing or purchasing property.
- Meeting or exceeding applicable environmental laws, regulations and standards that relate to the company, including voluntary standards to which OpenText adheres.
- Reporting annually and continually tracking progress, including participating in external reporting frameworks, as well as additional standards that may become applicable.

Minimizing waste, water, and energy

- Managing the consumption of natural resources used in day-to-day operations, such as energy, water, paper, and other resources.
- Pursue efforts to increase renewable energy consumption at owned and leased office and date centers, where possible
- Supporting efforts to minimize waste and prevent air, water and other pollution from our operations. Reusing where possible and purchasing less, as well as avoiding waste going to landfills by prioritizing recycling and other means of disposal.
- Prioritizing the procurement of sustainably sourced and packaged materials that can be re-used or recycled.

- Deploying an environmental management system (EMS) aligned to ISO 14001 across select sites to ensure that we can manage the environmental activities and impacts of our business.
- Working in collaboration with landlords and other partners to improve environmental programs throughout our global operations and examine options to integrate sustainable building features when leasing or purchasing property.

Education and awareness

- Participating in activities and programs to improve environmental education and protection, as well as pollution prevention and the conservation of natural resources.
- Communicating with internal and external stakeholders about the company's environmental, health, and safety performance as well as our commitments and corresponding progress.
