

OFFICIAL SWEEPSTAKES RULES

By participating, you agree to be bound by these Official Sweepstakes Rules and the decisions of the Sponsor (as defined below), which are binding and final on matters relating to this sweepstakes (“Sweepstakes”).

SPONSOR: OPEN TEXT INC.

Entries generated by script, macro or other automated means or practices, or by any means which subvert the entry process will be deemed void. In order to be eligible, entries must be received during the Sweepstakes Period.

LIMIT: One (1) entry per person and per email address throughout the Sweepstakes Period. Multiple entries will not increase your chances of winning. Entries received from any person or email address in excess of the stated limitation will be deemed void.

ELIGIBILITY: Individuals who registered, using their company email prior to the applicable Sweepstakes Deadline are eligible to participate.
